SECRETARY/TREASURER'S REPORT



After the first year of becoming acquainted with the role, the second year as Secretary/Treasurer has seemed to run much smoother. Bookkeeping duties of balancing the checking and savings accounts monthly and updating the budget to ensure we were sticking close to our projections were performed. Website maintenance has exceeded our projections. Expenses for NASPGHAN assistance are also higher than we predicted in part due to an increase in the rate they were charging per hour and their assistance with shipping the updated handbook. As you recall every member attending last year's meeting received a complimentary copy of the handbook. In addition we gave away 20 complimentary copies as enrollment incentives at the end of last year and have sold approximately 50 more books at a cost of \$40 each.

Again this year, Diane Kocovsky, Ryan Shonce, Lisa Philichi and I worked extensively on fundraising for our annual meeting. Mead Johnson, Nutricia and Abbott Nutrition again contributed to our meeting but we have had denials from grant requests to Shire, Sanofi and Janssen. We still have considerations pending from Salix, Abbvie and Prometheus. Thus far we have received \$25000 toward our projected program costs of \$28,570.

As of September 1st, 2015 total ASSETS = \$ 77,556.88 (last year \$71,134.79)

Checking Account Balance	\$ 47491.52 (last year \$41,074.91)
savings Account Balance	\$ 30,065.36 (last year \$30,059.88)

Goals for 2015 were:

- 1) Increase fundraising to a minimum of \$20,000 or more to cover annual meeting costs. I will try to find a conference/mentor to assist in these efforts. GOAL MET
- 2) Continue to convert our record keeping to primarily an electronic format. GOAL MET

Goals for 2016:

- 1) Possible development of an electronic file and process for grant submissions.

In place of the learning module a power point on the ABCs of Hepatology is in review. The goal is to have the Hepatology power point available in the member section for self-guided education. APGNN received 18 abstract submissions this year for the NASGPHAN conference (an all time record!!!). RESEARCH AND QUALITY IMPROVEMENT COMMITTEE

Living through the recent excitement and much anticipation of the visit of Pope Francis to Philadelphia in September, has made me realize that we have much to be thankful for. Highlights for this year include adding quality improvement to our purpose, promotion of nursing research, reaching out to national (we are invited members on NASPGHAN Research Committee); as well as being responsive to research and QI initiatives (NOVEL and below). Below are some highlights of this years accomplishments by the committee:

1. Diane Kocovsky and I attended the NASPGHAN planning meeting for the post graduate course and NASPGHAN conference in January 2015. At that meeting, we made important contacts that helped with the planning of this year's conference.
2. This years conference schedule offers opportunities for participants to attend NASPHAN lectures which help meet their individual learning needs. We will end the conference with a presentation by Psychology "BIO-BEHAVIORAL ASPECTS OF AND TREATMENTS FOR SPECIFIC GI CONDITIONS."
