**APGNN POLICY FOR NASPGHAN FOUNDATION/
APGNN SUSAN MOYER NURSING RESEARCH GRANT**

A GRANT based on this application is subject to the following conditions:

- A. NASPGHAN FOUNDATION requires the Grantee to affirm that there is no duplicate funding for the research. If an alternative application for support is activated, fully or partially, the Grantee will promptly notify the NASPGHAN FOUNDATION National Office to make necessary adjustments in funding.
- B. Results of research may be made available to the public through appropriate scientific channels. All publications resulting from work supported by NASPGHAN FOUNDATION must acknowledge support by the NASPGHAN FOUNDATION. Copies of any publication (including abstracts) must be provided to NASPGHAN FOUNDATION and APGNN. In addition, it is understood that the recipient will be asked to present the results of their research at an APGNN Annual Meeting.
- C. Grant support will terminate on the date the recipient ceases to work at the Grantee Institution, unless the NASPGHAN FOUNDATION has authorized advanced permission for transfer.
- D. Progress reports will be submitted as outlined in the announcement.
- E. Final narrative and financial report are due 90 days following the end of the one-year funding period.
- F. Investigations involving human subjects proposed and subsequently carried out in the application are to be endorsed by the Institutional Review Board (IRB) or other appropriate designated body of the Grantee Institution; and any research involving human subjects will conform ethically with the guidelines prescribed by the National Institutes of Health (NIH) and/or CIHR as appropriate, including the provision of suitable explanation to human subjects or their guardians concerning experimental design and all significant hazards, so that they may be in a position to provide appropriate informed consent prior to the investigations. Furthermore, approval from the IRB must be obtained prior to the release of grant monies.
- G. Research involving animals should conform to the current "Guide for the Care and Use of Laboratory Animals", approved by the council of the American Physiological Society, and with federal laws and regulations, including approval by an Institutional Animal Review Committee if required. Furthermore, approval from the Institutional Animal Review Committee must be obtained prior to the release of grant monies and this process must be completed within 9 months of the grant being GRANTED to continue to qualify for the GRANT.
- H. Wherever applicable, the research protocol will be reviewed and approved by the Institutional Biohazards Committee, as well as conform to NIH/CIHR guidelines. Furthermore, approval from the Institutional Biohazards Committee must be obtained prior to the release of grant monies and this



process must be completed within 9 months of the grant being awarded to continue to qualify for the GRANT.

NASPGHAN FOUNDATION/APGNN SUSAN MOYER NURSING RESEARCH GRANT

Description: This one-year grant is available to pediatric gastroenterology, nutrition and hepatology nurses to support research activities that have the potential to advance nursing care of patients and families of children with gastrointestinal, hepatobiliary, pancreatic or nutritional disorders. Monies are awarded in support of a meritorious research projects to study the nursing care of families and children with pediatric gastrointestinal, hepatobiliary, pancreatic or nutritional disorders.

Grant Term and Stipulations: The NASPGHAN FOUNDATION will award up to 3 grants ranging from \$500 to \$5000 for one year to the successful applicant. Institutional indirect costs are not allowed. A complete financial statement and progress report is required quarterly. All publications resulting from work supported by the NASPGHAN FOUNDATION must acknowledge their support. The recipient must attend the NASPGHAN/APGNN Annual meeting for acceptance of the GRANT. Dissemination of the research findings will be expected of the recipient via presentation at the 2014 Annual meeting and via publication.

Eligibility: APGNN applicant must:

- Be the primary investigator or a co-investigator in the study.
- Be a Registered Nurse with a minimum of a Bachelor Degree.
- Be a *full member* of the APGNN in good standing and maintain membership for the duration of the GRANT and research process.
- Be employed, either full time or part time and have a sustained interest in the field of Pediatric Gastroenterology, Hepatology and Nutrition Nursing in the United States of America, Mexico or Canada.
- Not have RO1, CIHR, PO1 (or similar) grant funding; recipients of US mentored grants such as a KO8, K23, or equivalent Canadian and Mexican National Foundation grants are eligible to apply.
- Not hold funding from any granting agency for a project with overlapping scientific objectives at the time the GRANT is made or during the one year period of the GRANT.
- Women and persons from underrepresented racial and ethnic groups, as well as individuals with disabilities are encouraged to apply.
- Submit application in English.
- Plan to obtain approval from their Institutional Review Board/Review Ethics Board if applicable. Monies will not be distributed until IRB approval is obtained with the exception of those IRB's requiring upfront fees with the initial application.



Review Procedures: The APGNN research committee, the APGNN president and a representative from the NASPGHAN FOUNDATION and potentially other ad hoc reviewers as invited by the research committee will review applications for the GRANTS. Primary emphasis is given to scientific strengths and innovation of the proposed work, impact on nursing care of children and families and commitment of the applicant and applicant's employing institution. Members of the review panel will follow strict conflict of interest guidelines. Contact between the applicant and committee members regarding applications is strictly prohibited and will lead to potential disqualification.

Application Instructions:

Applications for the NASPGHAN FOUNDATION/ Susan Moyer Research GRANT for APGNN must be submitted on or before August 2, 2014 through the NASPGHAN Foundation website..

Completed applications must include the following:

1. A biographical sketch in the NIH 398 format (available for download at <http://grants1.nih.gov/grants/funding/phs398/phs398.html>)
2. The research plan formatted as outlined below with one-inch margins and no less than 11 point Times New Roman or Arial font.
3. Page limitations and style requirements are strictly enforced. (No application more than three single spaced pages will be reviewed; references are not included in this maximum page count).
4. Description of the proposed project including:
 - Objective and hypothesis-State clearly the purpose of the study including how the project makes an original contribution to nursing care of children & families within our specialty; state concisely what the research project is intended to accomplish and/or what hypothesis will be tested
 - Needs assessment-why is this project important; provide the background for your project; evaluate existing knowledge & identify gaps that your project is intended to fill
 - Budget (\$500-\$5000)-personnel, supplies, computer costs, stipends, etc
 - How the plan will be implemented and by whom
 - Tools and/or instruments (i.e. questionnaire)-address how any tool will be used; any instrument used should be included in the appendix.
 - Procedure-describe the procedure(s) to be used for proposed data collection
 - Target population-describe the target population & characteristics of the subjects, the rationale for sample size, the sampling procedure & the setting for data collection



Outcome measures-what you specifically you plan to assess or develop; next steps based on your outcome
