The Treasurer shall manage all dues and reimburse Association costs at the discretion of the Full Board.

I agree that we need to have something regarding auditing. Definitely have Robin add to the Agenda. Below is the portion of NAPNAP's By-Laws that is exactly what you are addressing. I think this is really important especially since APGNN has grown a lot and, hopefully, will continue.

Section D. Financial Accounts

The Association shall keep correct and complete books and records of its accounts. An annual budget shall be developed and approved by the Executive Board. There shall be an annual audit/review of the financial records of the Association by an independent firm in such manner as directed by the Executive Board, the results of which will be reported to the Executive Board in a timely manner.


APGNN Treasurer Report

Greetings all! I am pleased to present an interim treasurer's report. This year, we have opened an additional interest bearing account for savings and are keeping part of funds there. Our income and expenses are as listed below – As you can see, the vast majority of income is from membership dues. Expenses thus far are for Accounting/Tax assistance, Website upgrade and maintenance, and reimbursement to NASPGHAN for journal subscriptions paid with membership dues, office and salary expenses. Conference expenses for this year are not yet known, but last year, we incurred expenses of around \$15,000. So, as you can see, we really depend on membership dues to support the educational conference as well as the day to day expenses of the organization.

As of 6/2/11, 132 members have not paid dues for 2011, and 64 of these also did not pay dues in 2010; these memberships are now inactive. Membership runs from January to January each year. If you have not paid 2011 dues, please consider "getting current" ASAP so that you do not lose your membership benefits, and we can continue to offer the excellent conference and other benefits that APGNN supports! Dues are paid to NASPGHAN (Kim Rose is our contact there if you are not sure of your status or last dues payment).
